## Stars on Ice Ticket Sweepstakes

(For ONLY the show Sunday May 5, 2019 at the Allstate Arena, Chicago, IL)

### Official Rules

**1. Eligibility:** Musselman's Stars on Ice Sweepstakes (the "Sweepstakes") is open only to U.S. legal residents who are at least 18 years of age as of March 13, 2019. Complete the form with first name, last name, mailing address, email address, and telephone number. (Email address and phone number will only be used to notify winners. Information will not be kept after the contest or used by the Sponsor/ Administrator.) All completed entry forms must be postmarked by Friday, April 12, 2019, and received by Friday, April 19, 2019. One entry per customer; one customer per email address.

**5. Drawing:** The administration and operation of the Sweepstakes and the selection of the potential winner is final and binding in all matters related to the Sweepstakes. Administrator will randomly select the potential Sweepstakes winner from all eligible entries received during the Promotion Period. On or around Tuesday, April 23, 2019, the Sponsor will conduct a random drawing of all eligible entries received for twelve (12) winners to receive the Prizes described below. The potential winners will be notified via email or phone call. Administrator shall have no liability for a winner's failure to receive notices due to winner's spam, junk e-mail or other security settings, winner's disconnected or inoperable telephone, or for winner's provision of incorrect or otherwise non-functioning contact information. Potential winner will forfeit the prize if no response is received within 48 hours. Receiving a prize is contingent upon compliance with these Official Rules. In the event that a potential Sweepstakes Prize winner is disqualified for any reason, Sponsor will award the prize to an alternate winner by random drawing from among all remaining eligible entries received during the Promotion Period. Total ARV of all Prizes: \$6840.00. Odds of winning a Sweepstakes Prize depends on the number of eligible entries received during the Promotion Period. (Meet and Greet show performers are subject to change and do not include the entire cast.)

**7. The Prizes:** Prizes are non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute the prize for one of equal or greater value if the designated prize should become unavailable for any reason. Winners are responsible for all taxes and fees associated with prize receipt and/or use.

**8. Release:** By receipt of any prize, winner agrees to release and hold harmless Knouse Foods, Inc., Facebook, Inc., and each of their respective subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies, and prize suppliers, and each of their respective parent companies and each of such company's officers, directors, employees and agents (collectively, the "Released Parties") from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Sweepstakes or receipt or use or misuse of any prize.

**9. Disputes:** Except where prohibited, entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for Pennsylvania; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred up to the total ARV of one (1) prize, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and
